

Contract awarded for bridge at Forks of the Credit Park

The contract for the Cataract pedestrian bridge replacement in the Forks of the Credit Provincial Park was recently awarded by Caledon council to the consortium of Bianchi Contracting Inc., Algonquin Bridge Inc. and Beech Engineering Ltd. at an upset cost of \$198,000 plus GST.

A wooden bridge was demolished last October and the area secured for the winter months. Town staff then researched the market for alternative bridge designs and determined that a self-weathering prefabricated steel bridge was the most appropriate type of structure.

The Ministry of Natural Resources has proposed to fund half of the cost of the bridge replacement to a maximum of \$100,000 in exchange for the transfer of certain parcels of Town-owned lands within the Forks of the Credit Provincial Park.
